Committee Updates

Strategic Enrollment Management (SEM) (J. Rubalcaba): Jessica Rubalcaba reported that subcommittees of SEM were tasked with defining 3 to 5 actionable goals, and that they will be reviewed at the next SEM meeting which will be on October 9th.

Business and Facilities (G. Abezetian): Garrick Abezetian reported that the college will be removing building names other than the primary letter building identifier, and that the committee had discussions regarding policy of having open or locked classroom doors. There was also some discussion about equipment standards on campus and how they are communicated.
