- Description: Youth Educator Grant projects provide opportunities for youth in the North Central Region to learn about Sustainable Agriculture (farming and ranching that is ecologically sound, profitable, and socially responsible). Educators use the grants to encourage young people and their parents to try sustainable practices and see sustainable agriculture as a viable career option.

- Description: This is a one-year grant to enhance and promote student learning outcomes through equity-centered student services programming, particularly for underrepresented racial minorities.

- •Project Title: Arts and Foreign Language Education

AFL programs in Illinois schools have increased student participation, funded musical and language courses, funded new faculty positions, and provided supplies and resources. Funding is available for each area up to four years, with one year of planning and three years of implementation.
